Subject: Ethiopian Orthodox Christians, Amharas and other Ethiopians Massacre by Radical Terrorist Querros: Appeal to the Ethiopian Government and the International Community

We, Global United Ethiopians Movement for Justice members, as concerned Ethiopians, living outside our native country, Ethiopia, have been closely following what has been unfolding in that ancient country. Ethiopia is a country where more than eighty different ethnic groups with common shared values and most major religions such as Judaism, Christianity and Islam have been practiced and worshipped in a unique and harmonious way for centuries. The Ethiopian people are known for their hospitality, religious tolerance, freedom seeking, and unified confrontation against any form of foreign invasion or aggression. The Ethiopian history witnesses these frank realities and attributes. Ethiopia was ruled by monarchy until 1974.

In the last forty or more years, however, the people of Ethiopia have been subjected to tyranny and authoritarianism. The last three decades have been years of darkness and institutionalized injustices that have caused unprecedented human tragedies and setbacks never seen in the entire history of Ethiopia. The EPDRF (Ethiopian People Democratic Front) Particularly dominated by TPLF (Tigreian People Liberation Front) ruled the country using religion, ethnic balkanization as weapons of repression, segregation, division, violence, hatred, injustices, wanton killings, disappearances, cruel imprisonments, mass murders and disabilities, to say the least. In the last eighteen months the situation has been progressively worsening. Beside the loss of countless lives, places of worship of the Ethiopian Orthodox churches as many as, 40-50 churches have been vandalized, set ablaze, and robbed of their unique antiquities, historical parchment, and treasures. Properties worth millions of dollars have been vandalized and robbed including more than 22 banks. No one has been held accountable for these cruel and inhuman actions. The new government led by Dr. Abiy Ahmed which is dubbed "Change" has

been totally hijacked, incapacitated or is unable to govern and is plunging into anarchism. He cannot restore rule of law and secure peace and security of the people he rules. Peace and security and rule of law have been greatly compromised since he came to power in April 2018. He cannot control his own constituency known as Oromia Regional State or his party, ODP (Oromo Democratic Party). Extremists, ultranationalists and ethno nationalists such as OLF and Mr. Jawar Mohammed have been engaged in dismantling the centuries old social, economic, cultural and political fabrics of the Ethiopian people. Jawar is a Jihadist radicalized by Islamic terrorists who are hell-bent to destroy our country.

Jawar has organized Oromo youths consisting of 8-40 years of age in different age categories and trained them by bringing different extremist pseudo scholars from abroad or from within the country. These radicalized Oromo Youths are known as “querros”. The OMN (Oromo Media Network) is instrumental in agitating the barbaric Querros to commit crimes against humanity. Jawar is by far more dangerous not only to Ethiopia but also to East Africa and the world than are ISIS, Boko-Haram, AL- Shabab and Al-Quaida. He has been preaching to turn Ethiopia into Bosnia and Ruanda. This evil man is supported by hostile elements in the Middle East both financially and logistically. These forces aspire to turn the Horn of Africa under their sphere of influence in order to control the Red Sea and the surrounding regions endangering countries like Ethiopia, Israel and the world at large. This radical Islam propagator of hate speeches, inciting religious and ethnic violence has been above the law under Dr. Abiy's premiership. The government of Abiy Ahmed has been either unequivocally hostage of this Jihadist or perhaps an accomplice of the crime by its inaction being part of the problem. The most graphic crime committed by Jawar is the massacre that took place ten days back while the prime minister was visiting Russia. The radical Querros massacred an unknown number of Amhara children, women and the elderly, burnt multiple churches at the behest of Jawar Mohammed. 1. Stop the radical QUERROS from attacking innocent Amharas. They kill Amharas, non-Oromos and Oromo Christians by beating, slaughtering using machetes, cutting with sharp knives, eviscerating internal organs, enucleating (removing eyes) slashing female breasts, male genitals, cutting off the limbs, decapitating and burying them in mass graves.
2. Due process of law and justice must be served and perpetrators must be brought to justice and held accountable for their actions.
3. Condemn the religious and ethnic based savage killings of Amharas and other Ethiopians.
4. Label the Querros in the list of International Terrorism like ISIS, Al-Qaida etc. The Querros have lynched people, burnt people alive, and eviscerated internal organs alive. Radical Querros killed an unknown number of innocent civilians by mob beating with nailed sticks.
5. Bring the chief terrorist, Jawar Mohammed to face justice for the crimes he committed. This man is the 21st century Caliph who envisions the Ethiopian Christians to convert to Islam by coercion. Ethiopians have witnessed the most barbaric and savage human tragedy by this man and his insane followers, the radicalized Querros.

13. Imprison the criminals and release the innocents who confronted the savage Querros immediately. In Ethiopia innocent and victims of the brutal attack have been arrested while the killers or those who have committed the crimes have been rewarded under EPRDF regime led by Prime Minister Abiy Ahmed.

14. To request the evil constitution, which is the root cause of all crimes, should be suspended and a new inclusive and impartial constitution be drafted and ratified by the people. The new constitution must partition the country based on natural and physical boundaries rather than language and race. The people of Ethiopia must be free to move from place to place in the country, work and acquire property anywhere in the land unlike the present situation, which prohibits these rights.

15. Demand the world community to exert pressure against the Ethiopian government to hand over Jawar Mohammed to face trial before the International Criminal Court in the Hauge.

16. Pinpoint high officials in the government are also suspected to participate in committing crimes and support Jawar Mohammed since they have not carried out their prerogatives as promulgated by the law. They have officially described the incident as conflict instead of mass murder or carnage.

17. Bring the radical Querros before the law and dismantle their structure, hold them accountable, also bring the Oromia law enforcement bodies before the law since they have participated in the commission of the crimes either by action or inaction.

18. Ban the Oromo Media Network and take legal action against the criminals running it. Also condemn Shimelis Abdissa, the Head of the Oromia region, for protecting Jawar Mohammed calling him a “dear brother” who should be shielded by the Oromia government.

19. Condemn those Abba Ghedas for fomenting violence in Bale Robe indicating they are mortal and implacable enemies of the Ethiopian people in general and the Amharas in particular.

20. We demand the crimes committed and the perpetrators who organized and carried out these crimes must be investigated by independent international investigators.

We are finally requesting the world community and governments to deploy peacekeeping forces in Oromia until a new constitution is drafted and ratified by the representatives of the people and call upon the Ethiopian government to restore peace and security in the country to avoid an imminent bloodshed.
